This Memorandum of Understanding is made on the 08th day of December, 2021, between <a href="CHRIST COLLEGE">CHRIST COLLEGE</a>, PUNE having an address at Pune Nagar Road, Pune-411014 and <a href="RAJAGIRIBUSINESS SCHOOL">RAJAGIRIBUSINESS SCHOOL</a> having an address at Rajagiri Valley P. O, Kakkanad, Kochi. Kerala-682039.

#### WHEREAS:

RAJAGIRI BUSINESS SCHOOL, KOCHI and CHRIST COLLEGE, PUNE, recognizing the value of cooperation, have agreed to enter into this Memorandum of Understanding (MOU) regarding academic collaboration. The purpose of this non-binding MOU is to make possible and to institute academic exchange of students and faculty members of 'RAJAGIRI COLLEGE OF SOCIAL SCIENCES AND RAJAGIRI BUSINESS SCHOOL- KOCHI', and the 'CHRIST COLLEGE, PUNE', based upon the principles of mutual equality and the reciprocity of Benefits.

### **Both Parties HEREBY AGREE that:**

#### A. STAFF PROGRAMME

Each Party will accept students and visiting faculty members from the other Party. Host party will arrange for board and lodge for the visiting teachers and students and the host party will bear all expenses of the visiting teachers and students related to board and lodging, provided the visit is for a maximum of two days beyond which the visiting party will have to bear the expenses or a share of it as per the host parties decision. All other expenses, including the travelling expenses, will be the responsibility of the visiting party.

Subject to availability, the host Party will provide the normal services for visiting scholars including library and laboratory facilities. The host Party will assist the visiting scholars, as far as possible, in matters of health, and local custom.

### B. JOINT RESEARCH PROGRAMME


The two Parties will seek opportunities to cooperate in research. The details of specific research proposals will be determined by the mutual agreement of both colleges. The form of cooperation may vary with goal of each project.

The two Parties agree that, in the event of research collaboration leading to patent rights, copyrights and other intellectual property rights, a further separate written agreement must be entered into in each case in accordance with the policies of

#### C. <u>ACTIVITY EXCHANGE PROGRAMME</u>

To facilitate academic and cultural interchange, the exchange of research materials, publications and information between the Parties will be encouraged. Each Party will invite the other, when appropriate, to participate in conferences, symposia and short visits.

#### D. STUDENT EXCHANGE PROGRAMME

The exchange of students will be encouraged and a Student Exchange Agreement will be drawn up to facilitate such exchange.

### E. COMPLIANCE WITH LAWS

Both parties will comply with all relevant laws in the jurisdiction in which it is in situ and all visiting scholars shall comply with all relevant laws in the jurisdiction of the host Party.,

#### F. NO AGENCY

Nothing is this MOU gives rise to a relationship of agency between the parties.

### G. NO JOINT VENTURE, PARTNERSHIP OR EMPLOYMENT RELATIONSHIP

Nothing in this MOU shall be relied upon to construe a joint venture, partnership or employment relationship between the Parties.

### H. NO TENANCY OR INTEREST IN PROPERTY

Nothing in this MOU shall create or shall be construed to create any tenancy or to confer or be construed to confer upon one Party any interest in any, all or part of the grounds, building or premises of the other Party.


### I. TERMS OF RENEWAL, AMENDMENT, AND TERMINATION

This MOU shall remain in force for a period of three (3) years from the execution date at the beginning of this MOU, with the understanding that it may be terminated by either Party giving three months' notice to the other Party in writing. If this agreement is terminated by either party, each party agrees to carry out any obligations and responsibilities assumed prior to the termination date.

This MOU may only be renewed if, after a review process between the parties, the

### BUSINESS QUIZ COMPETITION







THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MoU") is made this 20th August 2017.

# Between the following Parties:

Christ College, 26/4 A, Matchwell Factory Road, Sainikwadi, Vadgaon Sheri, Off Pune Nagar Road, Opposite Weikfield IT Park, Pune, Maharashtra, India - 411014 (hereinafter referred to as "Christ College");


### And

Association of Chartered Certified Accountants of Adelphi, 1-11 John Adam Street, London, WC2N 6AU United Kingdom (hereinafter referred to as "ACCA");

ACCA and Christ College, shall hereinafter referred to collectively as "Parties" and individually as a "Party")

### WHEREAS: -

A. ACCA is a body incorporated by Royal Charter in accordance with the laws of England and Wales. ACCA is the global body for professional accountants and as such, aims to offer business-relevant, first-choice qualifications to people around the world who seek a rewarding career in accountancy, finance and management. ACCA, as at January 2016, has 178,000 members and 455,000 students, who it supports throughout their careers, providing services through a network of 91 offices and centres around the world.





- C. The Parties share common and strong interests in advancement of education and holistic learning and affording the opportunity for individuals of ability to pursue globally relevant qualifications to enhance their future career prospects and ultimately to maintain and develop the profession and the wider economy
- D. ACCA and Christ College that joint collaboration and efforts in exploring opportunities and establishing a cooperative relationship would benefit the Parties and students pursuing qualifications offered by both Christ College and ACCA.
- E. This MoU sets out below the general framework and intentions of the Parties for collaboration for facilitation of further definitive agreement(s).
- F. In achieving the objectives of this MoU, the Parties shall work on the basis of reciprocity in areas of mutual interest within the parameters of their laws, constitutions, regulations and/or policies.

# NOW IT IS HEREBY UNDERSTOOD as follows:

# 1. Purpose of this MoU

- 1.1 The purpose of this MoU is to set out the understanding between the Parties without any intention to create legal relations, rather in the spirit of mutual cooperation. Any collaborative ventures that may bind the Parties are subject to separate contractual arrangements.
- 1.2 ACCA and Christ College will endeavour to assist and support each other in the functioning of this MoU to mutually benefit the Parties, such as to, among others:
  - a) promoting ACCA's suite of qualifications and the ACCA designation at the campus of the Christ College to their students (current and prospective)
  - b) collaborate with each other to develop specific programmes that create opportunities for students to achieve the ACCA





- b) The Parties agree that the collaboration shall be undertaken and carried out by the Parties in such manner as may be deemed necessary and appropriate in the circumstances and as the Parties may agree upon.
- c) The Parties shall where feasible utilise their existing and mutual relationships globally and nationally to support further relationships and associations for the benefit of both Parties

# 2.2 Responsibilities and agreements of ACCA

ACCA shall, with regard to its obligations in respect of the collaboration, offer the following opportunities to Christ College

- a) providing support to Christ College faculty and lecturers with relevant train-the-trainer events and support from ACCA learning and content partners
- b) update Christ College on ACCA research and insights programme and initiatives, including funding opportunities for projects that would be of relevance and interest to the industry, and of beneficial to both Parties;
- c) contributing articles or case studies to be published in ACCA magazines on an annual basis

# 2.3 Responsibilities and agreements of Christ College

Christ College shall, with regards to its obligations in respect of the Programmes, be responsible for:

- a) providing platforms for ACCA to promote the ACCA suite of qualifications,
- b) promoting ACCA as its professional accountancy partners of choice
- c) consider the necessary requirements to promote and / or deliver ACCA based programmes at their campuses





qualifications. Such collaborations shall be agreed by the Parties and form part of further agreements.

- c) disseminating information in collaboration with each other, to students, about the accounting profession and the opportunities available to accounting and finance professionals
- d) joint seminars, conferences, common research projects and publications on ACCA and the accounting profession whilst other forms of co-operation may be arranged by the parties during the period of this agreement
- e) exchanging, by mutual agreement, academic and examination materials to facilitate teaching and training and preparing students taking ACCA examinations
- f) bring together mutual networks of employers to maximise placement opportunities for ACCA students at Christ College.
- g) promote this collaboration across the Parties' global networks. The scope and content of the promotional activities shall be discussed and mutually agreed by the Parties; and
- h) undertake any other activities that shall be mutually identified and agreed by both Parties at a later stage.
- 1.2 This MoU shall form the basis of consensus for the Parties to examine the feasibility of the collaboration until such time when any other manner of agreement is entered into by the Parties upon terms and conditions to be mutually agreed upon.

# 2. Responsibilities and agreements of the Parties

# 2.1 General responsibilities of the Parties:

a) The Parties shall use their respective best endeavours to promote and implement the collaboration to the best advantage of the Parties.





d) sharing business intelligence and networks with ACCA for both Parties' mutual benefit

### 3. Costs

The Parties shall each bear their own costs and expenses incurred in complying with their obligations under this MoU.

## 4. Confidentiality

The Parties agree to keep confidential any information which is disclosed or obtained and which is not publicly available or already known and not to disclose such information to third parties, otherwise than in accordance with the consent of the other party or as required by law or any relevant regulatory authority duty.

## 5. Validity and Renewal of the MoU

- 5.1 This MoU is valid and shall remain in effect for three (3) years from the date of this MoU and may be renewed upon the mutual agreement of the Parties, such renewal to be expressly agreed in writing by both Parties before the end of the initial three (3) year period.
- 5.2 Either Party may terminate this MoU by giving three (3) month's written notice to the other Party. Notwithstanding the expiry or the earlier termination of this MoU, the obligations of the Parties in any definitive agreement that is negotiated and executed in accordance with as a legally binding contract shall survive and remain binding on the Parties in accordance with the terms of that agreement.

# 6. Notices

The terms stipulated in this MoU shall not be amended, altered, changed or otherwise modified without the mutual consent of the Parties and such amendments, alterations, changes and modifications shall be made in writing and signed by the Parties hereto.

### 8. Name and Logo

Neither Party shall use, nor permit any person or entity to use the name nor logo (or any variation thereof) of the other Party without first obtaining the written consent of the other Party.

# 9. Non-Binding Nature of the MoU

The Parties acknowledge and accept that:

- 9.1 This MoU shall not constitute any partnership between the Parties.
- 9.2 Notwithstanding the statements and obligations herein, this MoU shall not create a legal relationship between the Parties and the Parties shall not be legally bound until and unless a definitive agreement has been negotiated and duly executed by the authorised representatives of Christ College and ACCA.





## 10. Mutual Cooperation and Relationship

- 10.1 The Parties realise that it is not feasible to adequately foresee and address every issue involving the collaboration of the Parties herein. Hence the Parties shall use their best endeavours to realise their expertise in carrying out the steps and measures necessary for furthering their mutual interest under this MoU in accordance with the spirit of good faith, equity, fairness, close cooperation, mutual assistance and if any dispute arises, the Parties shall use their best endeavours to agree upon such action as may be necessary and equitable to remove or resolve the cause or causes of the same.
- 10.2 The parties understand that their reputations are of critical importance and undertake not to take any action, in relation to this MoU or otherwise, which might damage the reputation of the other party.





Memorandum of Understanding

The two institutions shall seek to promote:

- a. Exchange of students
- b. Exchange of faculty members
- c. The exchange of academic materials and publications.
- d. Participating in seminars, symposiums, and other types of academic discussions,

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including those concerning salary, travel funding, health insurance, and housing will be worked out between the institutes. A separate agreement will be entered into giving such details including term of exchange of any intellectual property.

### Students Exchange and Educational Agreement

The Bhopal School of Social Sciences, Bhopal and Christ College, Pune agree that student exchange will be guided by principles listed below A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host cinstitution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

Exchange students will be selected by mutual agreement between the home institution and the host institution.

DIST BY OP An exchange student will continue to be treated as full-time student at his/her home (MP) FEDIA exchange student as full-time "exchange" student at the host institution.

- O3: The Bhopal School of Social Sciences, Bhopal and Christ College, Pune agree to provide suitable accommodation and living expenses for student exchange.
  - 4. To exchange information on research and educational programs.
  - 5. The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes.

#### Validity

The Memorandum shall remain in force for a period of FIVE years i.e from academic session 2018-19 to 2023-24 commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

#### **Termination**

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution. Termination would not affect students already engaged in the Agreement.

### REPORT ON STUDENT EXCHANGE PROGRAM (2018 – 2019)

### Day 1
