While sending the list, include both the First attempt exam entry and resit exam entries of the students separately in the format shared with you which is required to be send to ACCA for the Result Service to maintain the ALP Status of the Centre.

Please Note the following:

1. Send the First attempt exam entry and resit exam entries of the students separately in the attached format, clearly mentioning the students attempts.
2. Exam Entry is applicable for the Students registered under ISDC Direct Scheme who are attempting their Examination (First Attempt) from F5 paper onwards.
3. 1st Attempt of Exam entries of each paper will be done through ISDC Direct. Resit Exam entries are to be done by students themselves.
4. Please send the Exam entries of the students who are not awaiting their December 2019 Result along with the fee so that their exam entries can be processed early.
5. FIA Student should clear their FIA Papers and get transferred to ACCA to be eligible for January exam entry. Process of transfer from FIA to ACCA takes its own time.
6. Exam Fee of the students is to be cleared before the exam entries is sent to us.
7. Please use the drop down menu to enter the exam entry as the Paper names have changed as per the new ACCA updates.
8. Please use the attached format and send us the file with all the details correctly filled in. Exam entries with Incomplete or incorrect details will not be processed and Do Not change the format shared with you.
9. No further changes to the exam entries will be entertained after the above mentioned dates.
10. Exam time slot and Centre will be booked based on the availability for the session CBEs.
