PURPOSE OF MOU:

In particular, this MOU is intended to

- . To understand the Concept of Internship Program which will be useful in near future.
- Organize Expert / Guest Lectures from different Industries/Sectors for students during the course of Internship program to enhance their skills.
- All the commercials will be discussed and approved after mutual consent of both parties before commencement of the Internship Program.
- The college faculty should notify 7 working days in advance for preparing the syllabus for the Internship Program. This will be solely depending upon the college time table and schedule. Hematite will adhere to the provided schedule.
- Certificates will be given to the students after successful completion of the Internship program. The students have to submit his project on or before the given time failing which he /she will not be eligible for the completion certificate.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SETFORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

Clause 1

CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the First Party.

Clause 2

SCOPE OF THE MOU

- 2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
- 2.2 The Second Party will give valuable inputs to the First Party in teaching/ training methodology so that the students fit into the industrial scenario meaningfully.

- 2.5 The Second Party will extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.6 The Second Party will actively engage to help the delivery the students of the First Party into Internship Program.

Clause 3

VALIDITY

- 3.1 The validity of the agreement is for Three years from the date of agreement. The agreement will be renewed newly after completion of Three years with mutual consent from both the parties.
- 3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
